Sir,

With reference to your application on the subject noted above, I am directed to convey the approval of the Director of Education, Delhi to grant recognition to your school from classes Ist to VIII (without Aid) w.e.f. 1989-90 session subject to the fulfilment of the following terms and conditions:

1. That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination on caste and creed and preference shall be given to the students of the areas concerned.
3. That the school shall appoint more full time qualified and eligible staff for all the classes of the school as per the present norms of the department and the proof should be placed to the D.O. for verification.
4. That the school shall equip the science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students. Material worth Rs. 1,000/- shall be purchased during 1989-90 and a list be furnished to the Education Officer for verification.
5. That a proper library shall be established and facilities for reading to a staff also be made available for students as well as teachers. More approved standard books shall be purchased. Books as per the ratio of 10 books per student will be made and facilities of reading room will also be provided immediately and other books worth Rs. 5000/- be purchased by the start of next session, and the list of books will be furnished to D.O. for verification.
6. That the school shall purchase sports material shall be purchased for a 10-100 games during the year 89-90.
7. That the school shall strictly abide by the provisions of Delhi School Education Act and Rules, 1973 and payment shall be made as per the section 10(1) of Delhi School Education Act, 1973 to all the employees through crossed cheque and the amount of Rs. 1000/- shall be concerned D.O.
